Subject: **Significant domestic agreements of the Issuer's subsidiary**

Legal basis: Law on Offer, Art. 56, Par.1 Item 1 – current and cyclic information

Contents of the report:

The Management Board of KOPEX SA with its registered seat in Katowice (the Issuer) informs that today has been aware of receiving on 29 August 2011 by Rybnicka Fabryka Maszyn RYFAMA SA with its registered seat in Rybnik (the Issuer's subsidiary) two agreements signed with Kompania Węglowa SA based in Katowice.

The Parties of both agreements dated 8 August 2011 are RYFAMA SA – Contractor and Kompania Węglowa SA, Marcel Coal Mine – Orderer.

Subject of the first agreement is „Financial lease together with supply of the new GROT 850 scraper beam stage loader produced by RYFAMA SA“.

Subject of the second agreement is „Financial lease together with supply of the new RYBNIK 850 scraper armoured face conveyor produced by RYFAMA SA“.

Total value of both agreements: PLN 7,527,029.26 + VAT

Value of the first agreement: PLN 2,926,116.26 + VAT

Value of the second agreement: PLN 4,600,913.00 + VAT

Term of the agreement: 36 months from 31.10.2011

Stipulated penalties (according to the Regulation of the Minister of Finance): Each Party is obliged to pay the other Party stipulated penalties amounting to 10% of the net value of the subject of the agreement in case of renouncing the agreement by any Party due to reasons caused by that Party. If the losses born in fact exceeds the stipulated penalties the Parties retain the right to claim additional compensation. The Parties agreed that payment for the period of use of the subject of the lease will be spread over 36 monthly installments.

The criterion of recognising an agreement as a significant one is exceeding by it of 10% of bounds pertaining to the Issuer's equity capital (the Issuer's equity capital amounts to 1,344,750 thou PLN, in compliance with data included in the published report for Q1 2011) and fulfillment of the criteria set forth in Par.2 Cl.1 Item 44) and Par.2 Cl.2 of Regulation of the Minister of Finance dated 19 February 2009 on current and periodic information (...). In the past 12 months the Issuer's subsidiaries signed with this customer and its subsidiaries agreements amounting altogether to

165,696 thou PLN (including this one). The Issuer informed about the last agreement with this customer in the current report RB 118/2011 dated 26.08.2011. The highest value agreement from among all the agreements signed in the past 12 months is the agreement the Issuer informed about in the current report RB 89/2010 dated 4.07.2011 that also includes information relating to the highest value agreement set forth in Cl.9 Items from 1) to 7) of the Minister of Finance Regulation dated 19 February 2009 on current and periodic information (...).
